Flow to Fit Yoga/Bliss Yoga Retreat Agreement ("FTF/BY Retreat")
Terms & Conditions:

1. I understand that I am participating in yoga/hiking and other retreat activities taught or led by Amie Meleshkewich and Lilia Wills of Flow to Fit Yoga & Bliss Yoga, respectively (together the "FTF/BY Retreat"), during which I will receive instruction about yoga, hiking and participate in other physical activities. I recognize FTF/BY Retreat requires physical exertion that can be strenuous. I am fully aware of the risks involved.
2. I understand that it is my responsibility to consult with a physician prior to and regarding my participation in FTF/BY Retreat. I represent and warrant that I am physically fit and have no medical conditions that would prevent me from participating in FTF/BY retreat. I assume full responsibility for any injuries or damages, known or unknown, which I might incur as a result of participating in of FTF/BY Retreat. I knowingly, voluntarily, and expressly, waive any claim I may have against Amie Meleshkewich and/or Flow to Fit Yoga and Lilia Wills and/or Bliss Yoga for injury or damages that I may sustain as a result of my participation in FTF/BY Retreat.
3. I understand that the cost for this FTF/BY Retreat is \$2050 per person (**\$300 non-refundable deposit due by July 1st) final payment of \$1750 due by August 1st, 2020**. This includes airfare, accommodations, 16 meals, tours and yoga sessions daily. I further understand that the activities are weather permitting and may need to be held indoors or cancelled altogether and that I will NOT be refunded or discounted for cancelled classes/tours due bad weather or unforeseen events or for any unused portion of the retreat.
4. I understand that my deposit for the FTF/BY Retreat is not refundable (unless canceled by the organizers), and that the final payment is due August 1st after that NO refunds will be provided to me and my registration is not transferrable to another party.
5. I understand and accept that the FTF/BY Retreat organizers may, from time to time, have to alter some details of the retreat (e.g., yoga teacher, class times or tours). If my accommodation has to be changed, FTF/BY Retreat organizers will do their utmost to provide accommodation of a similar rating.
6. I understand that the FTF/BY Retreat organizers reserve the right for any reason to cancel the retreat. In particular this retreat requires a minimum number of 12 participants to have booked 60 days before the start date. If this minimum number is not reached by that date the organizers reserve the right to cancel the retreat and refund all payments made to date by me.
7. I understand that FTF/BY Retreat organizers accept responsibility for ensuring that the retreats are supplied as described and that the services provided are to a reasonable standard. FTF/BY Retreat organizers do not accept any liability for cancellations, delays or changes caused by war, threat of war, viral outbreaks, terrorist actions or threats, closure of airports, civil strife, industrial action, natural disaster, technical problems to transport, staff cancellations, unforeseen changes in my personal circumstances or other events beyond their control. FTF/BY Retreat organizers are not liable for any loss of, theft of or damage to my personal property. I understand that is it my responsibility to ensure that my possessions are kept safe at all times.



8. I agree to inform FTF/BY if I have a problem during the retreat, immediately and they will endeavor to put things right. FTF/BY however, cannot be responsible for the individual behavior of any group member or other guest sharing your accommodation.
9. I understand that Travel insurance is highly recommended that covers the activities of this retreat as well as unexpected cancellation, sickness, losses and all the usual risks.
10. I understand that this requires documents necessary for international travel and I will need a valid passport for this trip. I further understand that I am responsible for securing my passport and any other important travel documents and personal effects.
11. I understand that this is a group retreat and all of the sessions, tours, meals will be enjoyed as a group. I may choose not to participate in any of the activities at any time, but there will be no refunds for missed tours or yoga sessions.
12. I hereby grant full permission and authority to Flow to Fit Yoga, LLC/Bliss Yoga, LLC to use for any legitimate purpose and with out payment or compensation, any photographs, video, motion pictures, sound recordings of any event or activity in which I am involved which depicts my person.
